Terms & Conditions

1. Booking Confirmation and Payment ~ Provisional bookings can be made and a date held for up to a maximum of 7 days from which time a non-refundable deposit of £150 will be required to secure the date.

All food and drink choices together with provisional numbers should be advised no later than 14 days in advance of the event.

Final numbers should be confirmed and final payment should be made no later than 10 days in advance of the booking. Any reduction in numbers after this date will not be refunded. Any increase in numbers will be at the discretion of Slater's and will be chargeable at the time of request.

2. Cancellation ~ In the event of a cancellation there will be a charge of :

14 days in advance 100% of the total anticipated charges

ANY REFUNDS DUE TO THE CUSTOMER WILL BE PAYABLE WITHIN 28 WORKING DAYS OF THE DATE OF CANCELLATION

3. Access and Timings ~ The Customer must ensure that The Venue shall be cleared of materials, equipment and decorations brought there, including those brought by external suppliers within the time mutually agreed between The Venue and The Customer. The Venue holds no responsibility for items left after this time. Events must finish at the time agreed when booking and an extension of time may not be possible.

4. External Suppliers ~ All external suppliers can only enter the venue at the agreed times provided to The Customer and their information must be relayed to Slaters prior to your event. The Customer should ensure that entertainment contractors provide The Venue with a copy of their public liability insurance and relative P.A.T certificates. Such certification must be received prior to your event. It is the responsibility of The Customer to ensure all external suppliers receive a copy of these terms and conditions and agree to abide by them. In the event of a failure by external suppliers in this respect, The Customer will be accountable.

5. Buffet Food ~ The buffet food will be provided from the time that has been agreed in the final meeting, and this can only be left out for a maximum of an hour and a half for hygiene and health & safety reasons.

6. Food and Beverages ~ The Customer will ensure that no food or beverages of any kind (excluding cake) are brought onto the premises. Slater's Country Hotel & Inn reserves the right to remove any food or beverages that have not been supplied by The Venue due to food hygiene reasons. Alcohol that has not been purchased on the premises is strictly prohibited.

7. Damage ~ The Customer is responsible to Slater's Country Hotel and Inn for any damage caused by their guests, suppliers or employees.

8. The Right To Exclude or Eject Persons ~ The Venue reserves the right to exclude or eject, as it thinks fit and reasonable, any persons from The Event or The Venue who it shall consider objectionable, including any external suppliers engaged by The Customer.

9. Equipment and Property ~ The Customer's own equipment and property is brought to Slater's Country Hotel and Inn at their own risk and Slater's Country Hotel and Inn accepts no liability for loss or damage. All personal items should be removed the following day. Any items not claimed within 21 days following the wedding may be disposed of.

10. Pricing ~ All prices will be confirmed upon booking your celebration. Price Variation ~ Slater's Country Hotel and Inn reserves the right to increase prices in the event of circumstances beyond control, e.g. increase in VAT.

11. Force Majeure ~ If Slater's Country Hotel and Inn is limited or hindered from hosting the event or providing any facility booked by the client due to circumstances beyond its control e.g. Government intervention, pandemics, acts of God, civil disturbance, war, national or local disaster, strikes, labour disputes, then the liability of Slater's Country Hotel and Inn to The Customer shall not exceed the amount paid by the client to Slater's Country Hotel and Inn in respect of the event.

Terms & Conditions continued.

12. Contract ~ When a booking is confirmed in writing a contract is deemed to exist. This contract shall be governed in all respects by English Law. It can only be modified by a supplementary written contract. Slater's Country Hotel and Inn will endeavor to provide the contracted event room. However, Slater's reserves the right to relocate the event to a different room/area of the hotel, whilst fulfilling all other criteria of the booking.

13. No oral representations or arrangements are recognised by The Venue and the conditions of this agreement can be modified only by a supplementary written contract. Both parties must sign the supplementary written contract.

14. Once booked and payment received The Customer agrees to the terms and conditions above and it is considered legally binding.
